NEW HELICOPTER LIMITED WARRANTY

MD Helicopters, Inc. ("MDHI") warrants each new helicopter to be free from defects in material and workmanship under normal use and service. This Warranty is limited to new commercial helicopters only and is not applicable to helicopters sold for military use.

MDHI's sole obligation under this New Helicopter Warranty is limited to the replacement or repair (at MDHI's sole option) of parts, which are determined to MDHI's reasonable satisfaction to be defective within two thousand (2000) hours of operation or two (2) years after acceptance, whichever occurs first. For warranty claims filed within the first year or one thousand (1000) hours, whichever occurs first, MDHI will pay one hundred percent (100%) of the cost of parts and labor at the current MDHI published labor rate to either in its sole discretion repair or replace the part. For warranty claims filed within the second year or after one thousand (1000) hours, whichever occurs first, MDHI will prorate the cost of the replacement part, or repair at the current MDHI published labor rate, based on the number of months or number of hours in service whichever occurs first, in accordance with the set proration schedule (Refer to Proration Schedule for New Helicopter Warranty). Replacement parts will be serviceable and will have at least the life remaining of life limited parts, if applicable. Parts covered under this New Helicopter Warranty with a service life of less than two thousand (2000) hours will be prorated based on their published service life.

Repair or replacement parts are warranted for the remainder of this New Helicopter Warranty period only.

Written notice of a New Helicopter Warranty claim must be provided to MDHI no later than thirty (30) days after the date of discovery of the defect.

This warranty does not apply to any helicopter or any parts that have either been repaired or altered outside of MDHI's facility or an MDHI authorized Service Center. **If, in its sole discretion, MDHI has determined that unapproved parts, or parts not manufactured or sold by MDHI, or an MDHI authorized source, have been installed anywhere on the aircraft, this New Aircraft Warranty shall be null and void.**

This warranty does not cover any part that has been subject to abuse, corrosion, erosion, negligence, accident or any other condition other than normal use and service. This warranty does not cover customer furnished equipment. Seller makes no warranty and disclaims all liability for consumables (wear items) which are defined as items required for normal and routine maintenance or replaced at scheduled intervals shorter than the warranty period. Consumables include but are not limited to engine and hydraulic oil, oil filters, packing and o-rings, anti-corrosion and/or sealing compounds, brush plating material, fluids, compounds and standard aircraft hardware such as bolts, nuts, washers and screws that are considered hardware readily available to aircraft operators from other sources. MDHI makes no warranty whatsoever with respect to engines, ignitions, starting devices, generators, batteries, instruments, including but not limited to indicators and communication, navigation, and identification devices.

MDHI Service Bulletins ARE CRITICAL and contain information related to FLIGHT SAFETY and general airworthiness. Compliance with a Service Bulletin is MANDATORY in order to maintain eligibility for warranty consideration under the New Helicopter warranty. Helicopters must be serviced and maintained in accordance with the MDHI technical manuals to maintain eligibility for warranty consideration under the New Helicopter Warranty

NEW HELICOPTER WARRANTY CLAIM PROCEDURE

The customer shall use the following procedure when making a claim under the New Helicopter Warranty:

1. A claim will be made to MDHI through an MDHI authorized Service Center, using a properly completed Service and Operations Report (SOR) form (<https://www.mymd.aero>).
2. The MDHI Warranty Department will review the SOR and either deny warranty coverage based upon the information contained in the SOR or indicate that the part must be returned to MDHI for inspection and further warranty consideration. Accordingly, unless warranty coverage is denied based upon the information provided in the SOR, all parts shall be returned to MDHI for such inspection, and all costs associated with the return of the part shall be borne by the customer. 3. MDHI reserves the right to withhold any warranty coverage determination until proper review and inspections are performed.

5. Replacement parts shipped prior to determination of warranty coverage will be invoiced upon shipment. Upon a subsequent warranty coverage approval, credit will be issued.
6. Claims for shipping damage will not be accepted after three (3) business days subsequent to receipt of shipment.

NEW PARTS WARRANTY

MD Helicopters, Inc. ("MDHI") warrants each part to be free from defects in material and workmanship under normal use and service. This New Parts Warranty is limited to new parts only and is not applicable to parts sold for military use.

MDHI's sole obligation under this New Parts Warranty is limited to the replacement or repair (at MDHI's sole option) of parts which are determined to MDHI's reasonable satisfaction to be defective within the earlier of one thousand (1000) hours or twelve (12) months from time of installation, whichever occurs first. In no case will a part be considered for warranty that has been installed more than twenty-four (24) months following original shipment date from MDHI. Repair or replacement parts are warranted for the remainder of the original New Parts Warranty period only. This New Parts Warranty excludes any and all labor associated with removal and installation of the warranted part.

Written notice of a New Parts Warranty claim must be provided to MDHI no later than thirty (30) days after the date of discovery of the defect.

This warranty does not apply to parts which have either been repaired or altered outside of MDHI's facility or an MDHI authorized Service Center. If, in its sole discretion, MDHI has determined that unapproved parts, or parts not manufactured or sold by MDHI, or an MDHI authorized source, have been installed anywhere on an aircraft, this New Parts Warranty shall become null and void.

This New Parts Warranty does not cover any part that has been subject to abuse, corrosion, erosion, negligence, accident or any other condition other than normal use and service. MDHI makes no warranty and disclaims all liability for consumables (wear items) which are defined as items required for normal and routine maintenance or replaced at scheduled intervals shorter than the warranty period. Consumables include but are not limited to engine and hydraulic oil, oil filters, packing and o-rings, anti-corrosion and/or sealing compounds, brush plating material, fluids, compounds and standard aircraft hardware such as bolts, nuts, washers and screws that are considered hardware readily available to aircraft operators from other sources. EXCHANGE OR REPAIRED COMPONENT WARRANTY

MDHI's sole obligation under this Exchange or Repair Component Warranty is limited to the replacement or repair (at MDHI's sole option) of parts which are determined to MDHI's reasonable satisfaction to be defective within the earlier of one thousand (1000) hours or twelve (12) months from time of installation, whichever occurs first, unless extended Warranty has been approved. Parts installed twenty-four (24) months after shipment will not be considered for warranty, Repair or replacement parts are warranted for the remainder of the original Exchange or Repair Component Warranty period only. Exchange or Repair Component Warranty excludes any and all labor associated with removal and installation of the warranted part. This Exchange or Repaired Component Warranty is not applicable to parts sold for military use.

Components provided under this Exchange of Repaired Component Warranty will have sufficient service life remaining on life limited parts to meet the next recommended overhaul period as applicable at the time of delivery.

In the case of components sent to MDHI for repair, MDHI only warrants those items which were replaced at the time of repair and the workmanship involved in replacing such item(s). The warranty for those replaced items is one year from date of MDHI shipment, or one thousand (1000) hours of operation, whichever occurs first.

This Exchange or Repaired Component Warranty shall NOT apply to any Exchanged or Repaired components which MDHI determines to have been repaired or altered outside the MDHI factory (or MDHI authorized Service Center) in any way so as to affect the stability or reliability of the part. If MDHI has determined that unapproved parts, or parts not manufactured or sold by MDHI, or an MDHI authorized source, have been installed, MDHI, may at its sole discretion void the warranty of the component, sub-system, system, or helicopter. This Exchange or Repaired Warranty does not cover any component that has been subject, in MDHI's judgment, abuse, corrosion, erosion, negligence, accident, or any other condition other than normal use and service. This Exchange or Repaired Component Warranty does not apply to or cover customer furnished equipment.

After determining to its satisfaction that the part or parts are defective, MDHI shall repair or replace the items at its discretion. If a valid claim is made within the stated warranty period MDHI will pay one hundred percent (100%) of the cost to either repair the part or provide a replacement. Repair or replacement parts are warranted for the remainder of the original part's or component's warranty period only.

A written notice of a claim hereunder must be given promptly to the manufacturer and in no event later than thirty (30) days after the date of discovery of defect.

Coverage is limited to the work performed and the materials provided during the course of the service. No additional warranties are granted for parts or components previously installed or customer furnished.

Parts installed during the service are covered according to the terms and conditions of MDHI's New Part Warranty.

MDHI's sole obligation under this Helicopter Service Warranty is limited to the replacement or repair (at MDHI's sole option) of parts, which are determined to MDHI's reasonable satisfaction to be defective within one thousand (1000) hours of operation or one (1) year after acceptance, whichever occurs first. Approved claims for labor will be paid according the schedule contained in MDHI's Labor Allowance Chart.

Repair or replacement parts provided are warranted for the remainder of this Helicopter Service Warranty period only.

Written notice of a Helicopter Service Warranty claim must be provided to MDHI no later than thirty (30) days after the date of discovery of the defect.

This warranty does not apply to any service work that has repeated, repaired or altered outside of MDHI's facility or an MDHI Authorized Service Center. If, in its sole discretion, MDHI has determined that unapproved parts, or parts not manufactured or sold by MDHI, or an MDHI authorized source, have been installed, MDHI, shall at its sole discretion void this Helicopter Service Warranty.

This warranty does not cover any part that has been subject to abuse, corrosion, erosion, negligence, accident or any other condition other than normal use and service. This warranty does not cover customer furnished equipment. 3. MDHI reserves the right to withhold any warranty coverage determination until proper review and inspections are performed.
4. If warranty coverage is approved, MDHI will pay the costs associated with the return of the repaired or replacement part to the customer.
5. Replacement parts shipped prior to determination of warranty coverage will be invoiced upon shipment. Upon warranty approval credit will be issued.
6. Claims for shipping damage will not be accepted after three (3) business days after receipt of shipment.

PRORATION SCHEDULE FOR NEW HELICOPTER WARRANTY

The following schedule will be applied when the helicopter has passed the first year of full warranty or one thousand (1000) hours time in service, whichever occurs first. This schedule represents the level of coverage remaining given the hours and months the helicopter has been in use.

This schedule applies to 369, 500N, 600N and MD900 series helicopters. Please refer to the New Helicopter Limited Warranty for further information.

LABOR ALLOWANCE

MDHI will include a labor allowance only for the repair or replacement of those items that are factory originals. If approved, labor allowances will be one hundred percent (100%) for twenty-four (24) months or two thousand (2000) hours, whichever occurs first. Labor allowance will cover the removal, re-installation and tracking of eligible parts and components. Claims for labor allowance must be submitted to MDHI through an authorized Service Center, and the work must be performed by an MDHI authorized Service Center, or a technician approved by MDHI in order to be eligible.

The Labor allowances are made only for removal/ installation of new, or newly overhauled, or repaired items unless covered under the new helicopter warranty. Labor allowances are based on information found in The Labor Allowance Chart.
